Inhalation of ducts and fumes may cause irritation of the respiratory tract and labored breathing and coughing. Sensitization, nausea, flushing of the face and ringing of the ears is also possible. Chronic ingestion may result in pericardia effusion, polycythemia, cardiac failure, vomiting, convulsions, and thyroid enlargement. Iron compounds may cause vomiting, diarrhea, pink urine, black stool, and liver damage. May cause damage to the kidneys. Irritating to the respiratory tract, they may cause pulmonary fibrosis if dusts are inhaled.
